I. Catalog Description:

This course explores the topics that address recently identified current events, skills, knowledge, and/or attitudes and behaviors pertinent to the technology or occupation and relevant to the professional development of the student. This course was designed to be repeated multiple times to improve student proficiency.

V. Course Content:

This course is a comprehensive study of labor leaders, the labor/management labor movement and the effective application of collective bargaining process throughout the United States.

VI. Learning Outcomes:

Upon successful completion of this course, student will be able to:
Identify 10 organized labor leaders who contributed to present day collective bargaining concepts, explain the concept of labor federation, discuss the concepts of wages, working hours, working conditions, and benefits as they relate to collective bargaining, incorporate the labor or management in recognition, dues check off, grievance and arbitration procedures, seniority, overtime, trace the process of a grievance through bargaining channels, apply federal and state laws and orders as they relate to collective bargaining.

Evaluation: Exams, Case Studies, written research project, oral presentation

VII: Course requirements and grade computation:

A. College Requirements:

1. A written comprehensive final examination, not to exceed three hours in length, shall be given at the end of each semester for each course at the regularly scheduled time.
