**I. Catalog Description:**

This course emphasis is on general principles of public management and strategies of dealing with internal and external systems. Topics include planning, decision-making and leadership models, organizational behavior, and resource management.

**IV. Method of Instruction:**

Content is presented through lectures, class discussions, pre/post-testing, outside readings/reports, and/or individual assignments.

**V. Course Content:**

This course focuses on identifying and explaining the use of analytical tools in public management, in addition to describing public managers' decision models and identifying the five basic budget formats in public management.

**VI. Learning Outcomes:**

**Learning Outcome 1:** The student will be able to explain and apply the analytical tools and theories in public management.

Performance Objectives/Methods of Measurement for this outcome:

The student will be able to:

1. Identify the theories of public management in the public sector by taking written exam.
2. Explain the role and function of a public manager through case study analysis.
3. Describe the public manager's tools of implementation of public policy through written exercises and in class group activities.

**Learning Outcome 2:** The student will be able to identify the decision making models and budgetary functions as well as explain the effective and efficient use of resources in the public sector of a public manager.

Performance Objectives/Methods of Measurement for this outcome:

The student will be able to:

1. Explain the budgetary techniques, effective and efficient use of resources a public manger utilizes in the public sector by taking written exam.
2. Identify the role of decision making role and function of the public manager in the public sector through case study analysis.
3. Describe the role of leadership models of a public manager on public policy implementation through written exams and/or oral presentations.

## **VII: Course requirements and grade computation:**

1. A written comprehensive final examination, not to exceed three hours in length, shall be given at the end of each semester for each course at the regularly scheduled time.
